### **Soccer Camp Partnership Opportunities**



The New Hampshire Soccer Association (NHSA) is offering partnership opportunities with soccer camp providers starting in 2021. While soccer camps tend to run mostly in the summertime – if your organization also runs camps throughout the year, there are no restrictions as to when you can take advantage of this opportunity.

NHSA offers two tiers of partnership to the camp organization.

#### **Tier One – State Sponsored Camp:**

##### **What's included (additional benefits may apply):**

- NHSA will provide and manage camp registrations, payments, and transactions
- NHSA will provide use of the state soccer fields at no cost to the camp (rent free)
- Restroom facilities
- Insurance coverage for all registered campers
- Marketing of camp details through NHSA distribution channels (provided by camp)
- A NHSA liaison to assist in direct communication between camp director and campers
- Camp registration contact lists
- 9v9 and 11v11 goals can be provided at no additional cost

##### **Camp Requirements (additional requirements may apply):**

- A minimum of one qualified coach for every 12-15 campers
- Fulfillment of the number of sessions as advertised
- All coaches and camp staff need a current and verified SafeSport and Risk Managed
- All coaches and camp staff are properly insured by the camp

All fees are set by the camp. NHSA will collect 25% and distribute the remaining balance to the camp director via check within 24 hours of completion.

#### **Tier Two – Camp Affiliate Member**

##### **What's included (additional benefits may apply):**

- NHSA will provide and manage camp registration, payments, and transactions
- Insurance coverage for all registered campers
- Marketing of camp details through NHSA distribution channels (provided by camp)
- Camp registration contact lists

##### **Camp Requirements (additional requirements may apply):**

- Fulfillment of the number of sessions as advertised
- All coaches and camp staff need a current and verified SafeSport and Risk Managed
- All coaches and camp staff are properly insured by the camp
- Training fields/facility that is safe for players to train on

All fees are set by the camp. NHSA will collect 10% and distribute the remaining balance to the camp director via check within 24 hours of camp completion.
